Educational Theme

Jesus: His Life, His Times, His Land, His Hebrew Faith

March 9 & 10 - Depart USA & arrive in Tel Aviv

You will be welcomed at the Tel Aviv airport by our representative and transferred to your hotel in Netanya to enjoy dinner before retiring for the night.

March 11 - Cana, Nazareth, Megiddo & Caesarea

Visit the Franciscan Wedding Chapel in Cana, site of Jesus' first miracle, before continuing on to Nazareth, Jesus' boyhood home (Matthew 2:23) and experience Nazareth Village, a recreation of village life at the time of Christ. Look out over Tel Megiddo (Armageddon) to view one of the most important archaeological sites in Israel. Today's last stop is Caesarea, a center of the early Christians where an angel visited Cornelius, the first Gentile believer (Acts 10), and where Paul was imprisoned for two years before appealing to Caesar. Overnight in Tiberias.

March 12 - The Galilee

Worship as you sail across the Sea of Galilee. Visit Capernaum, center of Jesus' ministry in the Galilee, and visit the synagogue built on the site where Jesus taught (Matt.4:13, 23). On the Mount of Beatitudes, contemplate the "Sermon on the Mount" (Matt. 5-7). Explore the Church of the Fish and the Loaves at Tabgha, traditional site of the feeding of the 5,000 (Luke 9:10-17). See the Chapel of the Primacy, where Peter professed his devotion three times to the risen Christ (John 21). In Magdala, once home to Mary Magdalene, visit a recently discovered first-century synagogue. Visit Sepphoris, the cosmopolitan Roman capital of Galilee until Herod Antipas built Tiberias. It is heralded as the traditional birthplace of Mary. Overnight in Tiberias.

March 13 - Travel to Jerusalem

Today we say goodbye to the Sea of Galilee and begin our journey south to Jerusalem. As our motor coach takes us through the Jordan Valley, visit the tel of Beit Shean where the bodies of King Saul and his sons were hung from the city gates (I Sam. 31). We will visit the baptism site at Qasr al Yahud before continuing on to see the panoramic view of Jerusalem before checking into your hotel for dinner and overnight.

March 14 - Jerusalem & Bethlehem

In **Bethlehem**, visit the cave revered as **Jesus' birthplace** and see the **Church of the Nativity** constructed over the site (Matt. 1:18-25, Luke 2:1-7). Gaze out over Shepherds' Field before heading to **Qumran** where the Dead Sea Scrolls were discovered in 1947. Ascend by cable car to **Masada**, Herod's legendary mountaintop fortress which became the last desperate stronghold of the Jewish Zealots against the Romans. You can still look down on the remains of the Roman camps and the siege ramp below. End your day with a dip in the salt and mineral laden waters of the **Dead Sea**. Overnight in Jerusalem.

March 15 - Jerusalem

Begin today with a scenic view from the **Mount of Olives**, where Jesus ascended into heaven (Acts 1: 9-12). Walk down the **Palm Sunday Path** to the **Garden of Gethsemane**. View the **Pool of Bethesda** (John 5: 1-31) where Jesus performed the Sabbath miracle, and sing a hymn in the **Church of St. Anne.** Visit Herod's **Antonia Fortress** where Jesus was brought before Pontius Pilate (Luke 23: 1 - 11). Walk the **Via Dolorosa**, "the Way of the Cross," and stand in reverence at the **Church of the Holy Sepulchre**. Learn about the Jerusalem of Jesus' day with a look at the First Century Model of the City of Jerusalem, now housed at the **Israel Museum**. The museum itself contains 10,000 years of archeological artifacts, as well as the **Shrine of the Book** exhibit that displays the Dead Sea Scroll containing the book of Isaiah. Overnight in Jerusalem.

March 16 - Jerusalem & the Old City


Enter the Old City and visit the **Southern Wall Excavations** of the Temple including the **Teaching Steps** and the **Western Wall**. Walk the **Cardo**, the ancient main street of the Old City once lined with shops, now partially restored. Stand in the **Upper Room**, revered as the site of the Last Supper (Mark 14:12-26). Mount Zion is also where you'll see **King David's Tomb**. Visit the **House of the High Priest Caiaphas** (Matt. 26:57) where Jesus was imprisoned for a night. Worship at the **Garden Tomb** (Matt. 27:33).

March 17- Return to USA or Continue on to the Petra Extension

- Mar. 19 Journey through Jerash, and then recross the border into Israel. Enjoy dinner before transferring to the airport for your return flight home.
